# Medicines: Essentials List

- 1950/2006/EC
  - list of substances essential for treatment of Equidae intended for slaughter
  - positive list not a negative list
  - withdrawal period not less than 6 months
- 470/2009/EC
  - amends 2001/82/EC
  - allows substances that bring added clinical benefit to be added to the list

# Terms of reference used by CVMP



Substances considered must bring added clinical benefit through:

- having different mode of action
- different pharmacokinetic or pharmacodynamic profiles
- different length of treatment
- different routes of administration

# Not approved by CVMP

#### Phenylbutazone

 - 'carcinogenic and teratogenic potential of PBZ did not support an inclusion in the list'

#### Halothane

 - 'well published user safety concerns were not outweighed by any potential added clinical benefit'

# Current position

 CVMP-approved list is awaiting public consultation and a decision from the Commission



### Other issues

- availability of medicines in different countries – 'pan European' licensing versus national licensing
- difficulties importing medicines under the Cascade from other European countries
- discrepancies between national marketing authorisations and European regulations

# In your country, which horses are seen as 'registered horses' according to Council Regulation 90/426/EC?

- All horses identified and registered = 11
- Only certain stud books = 1

In your country, do your passport regulations make provision for the suspension of the passport in an outbreak of notifiable/reportable disease?

• Yes: 6

• No: 7

# Summary

- 504/2008/EC mostly implemented
- some countries allow other methods of ID
- some countries allow non-vets to insert chips
- minority of countries have national databases
- registered horses has broad interpretation?
- 50% of countries have provision for suspension of passport if disease outbreak

# Common themes – work plans?

- national databases: importance, linkage of horse to location, removal of dead horses from database
- national licensing and availability of medicines
- protecting human health responsible use of medicines, illegal supply, AMR, horse identification
- disposal and unwanted horses: need for slaughter
- enforcement of transport regulations
- disease surveillance and preparedness
- clinical practice: gender and generational changes, quality of new graduates and training, defining best practice
- lay practitioners: dental technicians
